▶ REHP 2020 All members

- The contribution rate will remain the same.
- \$5 State Paid REHP, direct bill members, and survivor spouses will be notified via mail of changes to the monthly rate.

▶ REHP 2020 Non-Medicare

- No changes in 2020 to the plan offerings for non-Medicare members
 - Basic PPO
 - Choice PPO
 - Regional Custom HMOs
 - CVS Caremark for Rx
- No changes to copays or deductibles
- Open Enrollment October 21 – November 8

➤ REHP 2020 Medicare

- No change to the Part D SilverScript plan for Medicare eligible members.
- Effective January 1, 2020 all Medicare eligible REHP members will be enrolled in the Aetna Medicare Open Access PPO.

Why is the Commonwealth changing Medicare plans?

- PEBTF requested bids on behalf of the commonwealth for the Medicare business offered to REHP members.
- Aetna's bid provided comprehensive coverage that is projected to save the Commonwealth \$240M over the next 3 years.

➤ REHP 2020 Medicare

What is an Open Access PPO?

- An Open Access PPO provides members with access to any provider that participates in Medicare and accepts the plan.
- 99.79% of providers used by REHP members already accept the plan.

REHP 2020 Medicare

What are the costs with the Open Access PPO?

BENEFIT	COST
Preventive care (routine physical, mammogram, etc.)	Covered 100%
Primary Care Physician visit	\$20 copay after deductible*
Specialist visit	\$30 copay after deductible*
Urgent care	\$50 copay
ER (not admitted)	\$100 copay
X-rays, lab work	Covered 100%
Inpatient hospital care	Covered 100% after deductible*
Outpatient hospital care	Covered 100% after deductible*
Diabetic supplies	Covered 100%
Annual out-of-pocket maximum	\$2,500
Fitness membership	SilverSneakers®

*deductible waived for 2019 MHMO members in 2020

How does the Part B deductible work?

- The deductible is the amount you must pay in a calendar year before the insurance plan pays.
- Once a deductible is met, you are responsible for the plan copays.
- The deductible is reset every calendar year.

➤ REHP 2020 Medicare

How does the Part B deductible work?

- For members who were enrolled in an MHMO in 2019, the deductible will be waived in 2020.
- Effective 2021, all Medicare members will be responsible for the deductible.
